

CIV | National Video Game Day Giveaway Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING.

The Giveaway may only be entered in or from the 50 United States and the District of Columbia. Entries originating from any other jurisdiction are not eligible for entry. This Giveaway is governed exclusively by the laws of the United States. You are not authorized to participate in the Giveaway if you are not located within the 50 United States or the District of Columbia.

1. Eligibility. Participation open only to legal residents of the fifty (50) United States and the District of Columbia, who are at least 13 years old. Void outside the fifty (50) United States and the District of Columbia and where prohibited, taxed or restricted by law. Retweet the Giveaway Tweet with the hashtags #Civ and [#giveaway] to be entered into the Giveaway. Your tweet must include Giveaway Tweet and the hashtags #Civ and #giveaway.

You must be an active holder of a non-private Twitter account and be a follower of the **@CivGame** to be eligible to enter this Giveaway via Twitter (i.e., you must make sure your tweets are set to “public” and not “private”).
